- Call to Order and Roll Call: The meeting was called to order at 7:04pm. Attending: Byron Martin, Kristie Wallis, Frank Anastasio, Virginia Keith, Sharon George, Amelia Kellner, Patti Larrow-George (town council liaison), Marina Capraro (staff)
- II. Agenda Addendum: None.
- III. - IV. Adoption of Minutes review / discussion / action
  - A) Regular Meeting –April 13, 2021: A motion was made to adopt the minutes of the 04/13 regular meeting; seconded; all in favor; passed.
- V. Reports / General Business review / discussion /action
  - A) Classes discussion/action
    - i. Amelia's Herb Class Summary: Amelia reported a high turn out at her Herb Class event, hosted at Blueberry Hill Farm. She would like to do another on another property in the fall.
    - ii. Future classes: Classes will likely resume in the fall.
  - B) Killingly Community Garden meeting / review / discussion / action: Staff reported more progress at the community garden; the new waterline is in, all available garden beds are rented, and crops are in the ground. They will be hosting a work day on Saturday, May 15<sup>th</sup>.
  - C) Green News Newsletter progress report: Frank put out a newsletter in April to advertise the community garden, Amelia's herb class, and the Killingly Conservation Commission's happenings.
  - D) Tomato Festival 2021: The commission discussed the Tomato festival planning process; there has been no official word from the town on the status of the 2021 Tomato Festival.
  - E) Budget Update: A discussion ensured regarding the upcoming fiscal year (beginning on July 1st) and what will be done with the remaining Ag budget; a motion was made to request that the town move the Ag Commission's remaining funds into the Open Space Land Acquisition fund; seconded; all in favor; passed.

- VII. Other Items review/discussion/action: Frank inquired about the proposal at last month's meeting to begin editing the "Killingly Grown" Ag Brochure to update new farms and remove ones no longer in operation. The commission asked staff to begin this process.
