# IV. Adoption of Minutes – review / discussion / action

A) Regular Meeting – April 10, 2019 – Amelia made the motion to adopt, Frank seconded, no discussion, vote was 3 to 0, motion passed.

# V. Regulations – review / revisions / discussion / action

A) Town of Killingly Zoning Regulations Section 585 "Agriculture" - review of "final draft"

\* Update: The hearing before PZC was continued to May 20, 2019.

B) Borough of Danielson Zoning Regulations Section 585 "Agriculture" – review of "draft changes"

\* Update: This still has not been scheduled for a hearing before PZC.

There was discussion surrounding the right to farm act, state statute and town ordinance. A person has the right to farm "no matter what", the act only concerns itself with issues that may become a nuisance, and it does not stop someone from starting a new farm.
