# REGULAR MEETING MINUTES

Parking area at 1892/Sherman memorial was improved; DPW will help with signage. Waiting for discussed ECFLA improvements to occur. DPW cleaned up trees at Quandoc. No new updates for Chase and Mason Hill.
