  - a. **September 19<sup>th</sup>, 2021–Special Meeting Minutes:** Mike made a motion to pass the minutes, Jean seconded, passed 3-0.

  - a. **Quandoc Conservation Property – Walktober Event Sunday, October 24<sup>th</sup> at 1PM:** For Walktober next year, Mike discussed wanting to gear it towards kids. For this Walktober, there will be a kid's scavenger hunt to hand out. Mike will work on the trail Saturday morning, possibly leaf blowing and weed whacking.
