There is concern with the proposed activity to pipe and fill a portion of the drainage swale in order to have access to the garage from the remainder of the house lot.

B. Application #07-1438 Michael & Karen Susi for single family home with installation of septic system within 200' of wetlands/watercourses; Located at 174 Margaret Henry Road; GIS Map 232; Lot 6; 26 acres; Rural Development Zone.

**APPLICANT / PRESENTATION:** Gregg Glaude, Killingly Engineering Associates, was present to provide a brief presentation and submit revised plans. He noted the lot involved is an irregular shape with some wetlands at the edge of proposed activities associated to installation of the septic system. Nitrogen renovation calculations were submitted into the record. Silt fence to be installed and maintained throughout construction and inspected prior to installation of the system. The DEEP approval letter has now been received and submitted into the record.

The swale involved with this application is classified as wetlands and is therefore subject to IWWC regulations and permitting. There was commission consensus that without an engineered site plan a responsible and informed decision cannot be made.

C. Application #07-1439 Jeannette Chambers for conversion of existing barn to an accessory dwelling unit and installation of septic system 200' of wetlands/watercourses; Located at 374 Mason Hill Road; GIS Map 30; Lot 14; 9 acres; Rural Development Zone.

APPLICANT / PRESENTATION: Gregg Glaude, Killingly Engineering Associates, was present to provide a brief presentation. He submitted revised plans dated 6-26-17 for review. He reviewed the septic system design and noted it is within 100 ft of wetlands. Nitrogen renovation calculations were submitted into the record. Results are favorable. The DEEP approval letter has not yet been received but is expected any day.

**IWWC COMMENTS:** It was noted the Commission cannot approve the application without the NDDH letter.
