## **SPECIAL MEETING MINUTES**

Monday, July 10, 2017, 7:00 p.m.

1. Call of the Meeting and Roll Call: Vice Chairperson Kyle Zadora called the meeting to order at 7:00 p.m.

Members Present: Marcel Lussier, John Navarro, Stewart Rivers, Kyle Zadora. Member Absent with notification: Thomas Weaver. Alternate Member Present: Daniel Toth. Also Present: Community Development Administrator, Mary Bromm

Mr. Toth was seated as a voting member.

4. Unfinished Business:

a. KCS Roof Replacement Project: Mary Bromm has been in contact with the Architect Silver / Petrucelli regarding the "responsiveness" of the contractor at bid time and in bid documents. It was noted, PBC is allowed to deny a low bidder if it deems that there was a lack of responsiveness in bid responses. Apparently, Greenwood Industries indicated in its bid response that project completion would be 120 days instead of a substantial completion before the start of the school year.

Mary Bromm contacted Greenwood Industries about this issue and asked for clarification. The principals of Greenwood Industries explained that the 120 day completion date was in fact an administrative error and their intention was always to complete the project in 45 days prior to the start of school. In summary, Mary Bromm indicated, with that clarification, Greenwood Industries is indeed the lowest responsible bidder.

CLERK OF THE WORKS PROPOSALS: Mary Bromm has been in contact with CREC Expert Solutions since PBC awarded the Clerk of the Works services to CREC at their July 5, 2017 meeting. CREC has indicated, since their interview and award, there has been a need to change the bid proposal amount. CREC felt that they needed to add more persons to accomplish the PBC's goals which would cost additional money. CREC indicated this scenario would require more personnel and work than was planned for in the original estimate. The days would in fact be longer and meeting times would increase. In summary, CREC increased their bid proposal amount by \$15,000.
