Dear Members of the Killingly Planning and Zoning Commission:

My name is Lois Latraverse, 65 Island Road, Dayville, CT. I am the President of the Alexander's Lake Homeowners Association (ALHA) comprising of approximately 200 Lake residents. I am writing to you on behalf of ALHA concerning Frito Lay's building expansion plan (Site Plan Review Application #21-1262) that is before you this evening.

Dating back to the early 1990's, both Frito Lay and Lake residents have tried to be good neighbors and work together on issues that arose that impacted Lake residents with some being resolved, others not. ALHA hopes to continue this working relationship.

With that said, we have outstanding issues relating to complaints of noise emanating from the current Frito Lay facility that we have been working on with them for a year. The noise issue has not been resolved to date. We periodically deal with strong odors as well that are supposed to mitigated by stack "scrubbers".

Based on a brief expansion plan presentation provided to a small group of Lake residents by Frito Lay on May 17th, we believe this is an exciting opportunity for both the Company and the Town, However, we also are concerned that the expansion plan has the potential to exasperate our current issues and possibly create new ones.

It only seems reasonable to assume that increasing the number of production lines will result in more noise emanating from roof top equipment as well as significant increased noise from more truck and train activity on the Upper Maple Street side of the facility, not to mention increased odors resulting from the new production lines.

I believe there are commercially available solutions that can be mutually agreed upon by all parties and I hope that we can continue to work in a "neighborly" manner to resolve them.

I therefore encourage the Committee to consider these issues as you review and assess the Frito Lay expansion plans and assure that such plans adequately address these topics.

Thank you for the opportunity to participate in this process.
