- II. **Approval of Minutes**
  - A. **April 07, 2021– Regular Meeting:** A motion was made to adopt the minutes of the 04/07/21 Regular Meeting; motion seconded; all in favor; passed.

- IV. **New Business – review/discussion/action**
  - A. **Accomplishments from recent workdays:** A workday on May 01<sup>st</sup> yielded a lot of clearing of beds within the pollinator garden, and woodchips were spread to cover all the pathways within the donation and rental garden. Staff reported a successful sale of the glass panes that were taking up space in the shed, and the garden added \$240 to its budget as a result. Additionally, the new waterline was installed by the facilities maintenance team for the town, and there is now water directly in the garden. Plans for above ground irrigation to deliver water to the donation beds must be figured out. Staff and a few members agreed to meet at the garden on Thursday, 05/06 to determine what is needed for irrigation to obtain pricing.
  - B. **Crop planting schedule:** More kale, carrots, zucchini, and peppers will be planted at the next workday.

- C. **Assigning duties:** Assignments will be determined at the next meeting of the community garden.
- D. **Schedule another workday:** The group agreed to schedule a special meeting/workday on Saturday, May 15<sup>th</sup> at 8:30am.
