

**TOWN OF KILLINGLY**  
**ANNUAL TOWN MEETING MINUTES**  
**Monday, May 6, 2013**  
**(TO BE ADJOURNED TO MACHINE VOTE)**

The Annual Town Meeting of electors and citizens qualified to vote in the Town Meetings of the Town of Killingly, Connecticut, shall be held, pursuant to Section 701 of the Killingly Town Charter, in the auditorium of the Killingly High School, 226 Putnam Pike, Dayville, Connecticut on Monday, May 6, 2013 at 7:30 p.m. to consider the following:

1. To consider, modify and/or approve the following ordinance:

**ORDINANCE APPROVING THE OPERATING BUDGET FOR  
THE TOWN OF KILLINGLY FOR FISCAL YEAR JULY 1, 2013 – JUNE 30, 2014**

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF KILLINGLY that, in accordance with Section 1005 of the Town Charter, the budget for the Town of Killingly, Connecticut, for the Fiscal Year July 1, 2013 to June 30, 2014, in the amount of **\$13,644,533** allocated to General Government and **\$38,865,091** allocated to Education, for a total combined budget of **\$52,509,624** be adopted.

There were approximately 150 people in attendance. The meeting was called to order at 7:34 p.m. by Elizabeth M. Wilson, Town Clerk. She read the call of the meeting. The meeting was videotaped for public access on Channel 22.

Motion made by Lynn LaBerge, seconded by Tammy Wakefield, to nominate William St. Onge as Moderator of the Annual Town Meeting. Motion passed unanimously by voice vote.

The Town Clerk asked if there were any more nominations for Moderator. There were none.

Motion made by Lynn LaBerge, seconded by Dennis Alemian, to close nominations.

Voice vote on Mr. St. Onge's nomination: Unanimous  
Motion passed.

Mr. St. Onge explained the procedure that registered voters, who are U.S. citizens and who are at least 18 years of age, as well as those residents who are not registered voters, but who own property assessed at \$1000.00 or more on the October 1, 2012 grand list, will have an opportunity to speak or vote on the proposed Town and School budgets. Also stated that on the General Government Budget you must specify a line item you want increased or decreased with the dollar amount. Whereas, with the Board of Education you can only suggest an increase or decrease in the proposed budget (give a dollar amount), but cannot specify where to increase or decrease (bottom-line amount).

Motion made by John Hallbergh, seconded by Gerard Cinq Mars to adopt the Ordinance Approving the Operating Budget for the Town of Killingly for Fiscal Year July 1, 2013 – June 30, 2014.

The moderator asked for presentations from the Town Manager and the Superintendent. Bruce E. Benway, Town Manager, presented a Power Point overview of the General Government Budget. The Superintendent, Kevin Farr, presented a Power Point overview of the Board of Education Budget.

The Officials were informed by the Business Manager for Killingly Board of Education about a conversation with the State BOE @ 4PM the day of the meeting that we may need to readdress the Revenue from Educational Cost Sharing (ECS) based on the current proposed funding for BOE expenditures.

The following residents, electors and taxpayers spoke on the General Government Budget:

Charles Ferland, 86 Knox Avenue made a motion to eliminate under the Revenue Collection (Account #7) a part-time position in the amount of \$14,925.00, and to eliminate under Employment benefits (Account #61) contractual services to remove \$1146.00 from that account for a total of \$16,071.00. Lloyd Brazee, 33 Picabo Street, seconded the motion.

Motion made by voice vote, then by standing vote for clarification:

MOTION PASSED by 1 vote.

Donald Dauphinais, 69 Stearns Street made a motion to put back into contractual services (Account #43) \$200,000.00 for two additional residential troopers. Amy Dauphinais, 69 Stearns Street, seconded that motion.

Donna Bronwell, 699 Bailey Hill Road made a motion to add \$25,000 for Open Space Land Acquisition (Account #63). Margaret Weaver, 175 Thompson Pike, seconded the motion.

Voice Vote was called by the Moderator on the Motion:

The Majority voted against the Amendment. MOTION FAILED.

Motion made by voice vote, then by standing vote for clarification.
