- 1. Call to Order Town Engineer: David Capacchione called to order the solid waste organizational meeting at 6:00pm.

- 6. Finance Report: Jen Hawkins, finance director, provided a finance report for the meeting. David Capacchione noted that the figures show everything on track and there is nothing out of the ordinary. Discussion ensued about the permits purchased since July 1, 2023. David Capacchione gave options to lower the subsidy by raising prices of the permits, 3 trip passes, bag stickers, tires, bulky waste. It was decided that increases would be as follows.

Regular Permits from \$80.00 to \$95.00 / seniors will stay the same at \$40.00. 3 Trip Passes from, \$20.00 to \$30.00. Bag Stickers from \$5.00 to \$6.00 Bulky waste from \$0.10 per lb. to \$0.15 per lb.

Car Tires:

Under 17" from \$4.00 to \$5.00 Under 17"w/rim from \$6.00 to \$7.00 Over 17" and over from \$10.00 to \$12.00 Over 17" w/rim from \$16.00 to \$18.00 Tractor/Equipment tires from \$25.00 to \$30.00

No Household Hazardous Waste scheduled for 2024-2025 fy.
