# In Process

- 8. Wash bay at Town Garage (town property on southern end)? acquifer?

  <u>Status Update</u>: The Town has engaged with Silver, Petruccelli to prepare conceptual design, construction costs and evaluation of systems for this project. Staff is evaluating the proposed plans which will be presented to the Town Council in the coming months.
- Plan for spending CEBA \$\$
   <u>Status Update</u>: The Town Manager has recommended the use of a portion of the CEBA funding to offset the renovations necessary for the Community Center relocation. The remaining funds are dedicated per the agreement.
- 10. Substantive review of ordinances; ex. Noise ordinance, equip & certif operation <u>Status Update</u>: Various ordinances have been reviewed and modified. A substantive review was performed in 2017. However, the final modifications were voided due to inadequate posting.
- 11. More recreation activities-places
  - <u>Status Update</u>: Recreation has added several programs to their roster including pickle ball, senior movie, and collaborating with the Killingly Business Association on events. This is an ongoing effort by the Recreation Department to offer new and diverse recreational programing for the community.
- 12. Customer service ie: public works; what you do & what you say; training & accountability; attitude change needed
  - <u>Status Update</u>: New management of the Highway Department has focused on training. He reviews a training topic monthly and is actively registering employees for continuing education.
