**Subject:** Public Comments for 2nd Amendment meeting on 8/3/2021

I regret my inability to show up in person for this meeting as I already have prior engagements but I will submit a public comment for posterity and to ensure I at least get to voice my opinion in some way, to hopefully enrich the discussion and add my own viewpoint to many others.

The second amendment is an important right for Americans. But it is more than that - I believe it is the legal manifestation of an inalienable right that all people have, that being the right to defend themselves, their loved ones, and their property from harm. I would place it on the same level of right as freedom of speech, freedom from religious persecution, and the like - after all, those rights are all only defensible because of something like the second amendment. One cannot defend their rights to protest, their rights to the freedom of speech, or their rights to religion or the like without a right to defend themselves, their loved ones, and their property. And that right to defend should extend to the implements needed to defend those rights. The founding fathers knew this. They knew that a tyrannical government would grab for these rights because it makes it easier to impose tyrannical laws against a disarmed people.

This is not to mention that gun control laws typically only entrench the power of the rulers and take it away from the people. Indeed, that is their very purpose. This is why many of the laws against arbitrary things such as "assault weapons" and "high capacity magazines" exist, and why many of the requirements to circumvent prison time for these laws is a paid tax or fine. It is why the process to be able to *legally* purchase a firearm in our state is so rigorous and so expensive - to keep the implements of defending oneself both in general and from a tyrannical government out of the hands of the poor. It is a method of centralization of power around the elite and the rich, and an enemy to those who truly love the idea of liberty for every man and woman.

This is not to mention the many sporting uses for firearms, even those typically considered "assault weapons". I have seen plenty of people take down deer and other relatively large game animals with AR or AK-platform firearms the same as anyone else. Many people like to shoot recreationally with these weapons - I certainly do, and there are many just in our little town of Killingly who share that sentiment. This is not to mention, of course, the many reasons we may keep weapons to defend ourselves not against criminals or a tyrannical government but against nature - we know our state to have bears, coyotes, and various other wildlife that may be dangerous.

This may of course beg the question - "If people are using them for recreation, why does anyone need 'X' gun? Why can't they just be happy with 'Y' gun that we've deemed legal?" This question applies to things like the "high-capacity magazine" ban, and the answer is a nuanced one but allow me to answer with a question: Why don't they need it? One might say 'It will lessen deaths in case of a shooting event', but this is patently untrue. Any deranged criminal truly intent on hurting others will just acquire the banned magazines elsewhere or they will bring several of the legal ones and just reload them. If a person truly wants to hurt somebody, they will, regardless of laws made by reactionary politicians to make the people feel better but that do nothing to combat the source of the issue, ensuring tragic events will continue to happen.

Overall I think it an excellent idea to secure Killingly as a bastion for the Second Amendment in a state and region that, quite truthfully, does not respect it as a law or a right but rather a suggestion to be ignored. I have lived in Killingly almost my whole life, and I find that these sentiments are often shared, in some form or another, by the residents. Connecticut has a long history of firearms, the history they encompass of ourselves, our country, and the world - Colt, Smith & Wesson, Marlin, Sharps, Winchester - these are names that have deep ties to Connecticut, names that we should all have pride in.
