Our League for the most part operates solely on our own fundraising and community partners. We strive to be little to no burden on Town of Killingly.

Our facility is open to the public, along the River Trail, near the canoe launch. We are doing our best to maintain our facilities on this Town owned property.

We operate through many challenges, although we understand the publics need for recreation.

Some of these challenges are constantly finding hypodermic needles, beer and alcohol bottles, homeless living in our dugouts, one of our dugouts had a fire set in it for a homeless man to stay warm. We have had our concession stand broken into several times. Equipment sheds have been broken into.

There is one situation that we as an executive board are unanimously in favor of. Killingly Little League is requesting that the consumption of marijuana and marijuana bi-products be prohibited in our recreation facility. We have had passerby's smoking marijuana around and thru our facility while young players are trying to safely learn the game. I have had several reports of children feeling sick to their stomachs and feeling lightheaded. Our people have approached the individuals in question and they state it is their 'right' to use, while getting aggressive with our coaches.

Subject: American Rescue Plan Act Funding for Killingly Fire Departments

Dear Ms. Calorio and the Members of the Killingly Town Council,

I am writing to you on behalf of The East Killingly Fire District. As you may know, we operate on a \$200,000 annual budget, and have kept our mil rate at a low 1.8 percent for many years now. We pride ourselves on prudent spending and careful planning to anticipate large expenditures and budget accordingly. It has recently been brought to my attention that there will be discussion at the upcoming Town Council meetings about appropriation of grant funds from the American Rescue Plan Act to provide Lucas CPR devices and State-wide, high-band mobile radios to all six Killingly fire departments.

I cannot speak for other departments, but I can assure you that the East Killingly Fire District would not be able to afford these expensive, yet valuable expenditures without the funds from this grant. I am sure I don't need to reiterate how important and invaluable the Lucas device is, but I can say with confidence, that without this equipment granted to us, it would not be affordable on our modest budget. Currently in Killingly, only KB ambulance has a Lucas device, so by providing each Killingly fire department with these devices, it would greatly increase accessibility and coverage for the best chance of survival to people suffering cardiac arrest. The mobile radio units that would allow us to communicate with agencies state-wide in the event of a wide-spread disaster would also be unattainable to us without the funds from this grant.

On behalf of the East Killingly Fire District Board of Directors, the Chief and members of the East Killingly Fire Department, and the taxpayers and residents of East Killingly, I personally thank you for considering the disbursement of funds from the American Rescue Plan Act to provide Lucas devices and state-wide mobile radios to our department, as well as the other Killingly fire departments. Your support of this proposal is greatly appreciated.
