WHEREAS, it is important to maintain mental health and learn the symptoms of mental illness in order to get help when it is needed; and

WHEREAS, every citizen and community can make a difference in helping end the fear, ignorance and shame that for too long have surrounded mental illness, and discouraged people from getting help; and

WHEREAS, public education and civic activities can demystify mental health issues, promote early intervention, and help to improve the lives of individuals and families affected by mental illness;

NOW, THEREFORE BE IT PROCLAIMED BY THE TOWN COUNCIL OF THE TOWN OF KILLINGLY that October 4 through October 10, 2016 was recognized as Mental Illness Awareness Week to increase public understanding of the importance of mental health and to promote identification and treatment of mental illnesses; and

#### 8. Citizens' Statements and Petitions:

Jack Dusseault, Laurel Drive, feels the key to success for the proposed power plant is to use that area for an industrial park. He also stated that there are studies showing a 62% reduction in pollution since 1980 and feels there is plenty of water for the project.

Frank Aleman, Sawmill Rd, gave two documents to the Council, one from the CT Siting Council and one from ISO New England in order to point out some inconsistencies in data used by NTE. Lois Latriverse, 64 Island Rd., received a letter from NTE about the proposed power plant. She felt that NTE was being disingenuous and there was no mention in the letter of the Public Hearing scheduled for October 19<sup>th</sup>.

Sandra Bove, North Shore Rd, spoke about the rally on Columbus Day at Killingly Commons in Dayville to show citizens' opposition to the proposed power plant.

John Sarantopoulos, Tunk City Rd. spoke about the proposed power plant and feels that the Council has made a decision against the power plant without having all of the information necessary to make an informed decision.

Mr. D. Griffiths addressed Mr. Sarantopoulos' comments about sending a letter to the Citing Council.

Mr. Alemian spoke favorably about the Young Marines Red Ribbon Campaign.

Mr. Ide apologized for not being at the demonstration on Monday, as he was at the National Fallen Firefighters Memorial in Maryland.

Town Manager Hendricks commented that the October 31<sup>st</sup> deadline is a self-imposed one for a draft to be done. Negotiations will continue.
