  - A. Application #24-1585 Tracy E. Scraba, Revocable Trust, for demolition & construction of single-family residence w/driveway, well, and public sewer w/i the 200' upland review area); 6 Arnold Lane; Map IDs 4791, Alt ID 108-26.006 ALZOD / Rural Development Zone

**PRESENTATION / APPLICANT**: Normand Thibeault, Killingly Engineering Associates, was present to represent applicant.

Location of proposed residence is restricted due to proximity of overhead electrical wires. Design calls for use of staked haybales & silt fence in appropriate areas. Stockpiles will be located away from any potential moist spots on property. There was discussion on Alexander Lake water line, associated lease agreement, and relationship of this application with ALZOD Regulations applied.

**STAFF & ENGINEERING COMMENTS**: Jonathan Blake noted he and Dave Capacchione, Town Engineer, have reviewed this application and see no major concerns.

B. Application #24-1586 Christopher & Beth Fallon for proposed addition for garage, screen porch & studio w/i 200' of upland review area; 23 Wauregan Road, Map IDs 1959, Alt ID 217-70, Industrial Zone

**PRESENTATION / APPLICANT:** Normand Thibeault, Killingly Engineering Associates, was present to represent applicant.

The applicant has received Zoning Board of Appeals approval. There are not many options for building locations due to right-of-way easement associated to State of Connecticut highway line.

**SOIL SCIENTIST REPORT**: There was review of correspondence submitted by Joseph Theroux, Professional Soil Scientist, dated January 10, 2024. Mr. Theroux delineated inland, wetlands, and watercourses and alluvial/floodplain soils on this property.

**ENGINEERING COMMENTS:** Dave Capacchione, Town Engineer, indicated there are no negative impacts to sewer system as design calls for slab on grade.

C. Application #24-1587 Application #24-1587 Lewis & Tina Merchant for proposed filling of 2830 sq. ft. of wetlands to create yard area, construct garage & install pool w/l 200' of upland review area; 18 Kent Street, Map ID 3863, Alt ID 200-129, Medium density Zone

**PRESENTATION / APPLICANT:** Normand Thibeault, Killingly Engineering Associates, was present to represent applicant. Modified site plans were submitted as result of IWWC concerns.

It was noted the Town has worked on outlet pipe/catch basin nearby to assist in drainage; and that, areas of proposed filling do not hold water.

**SOIL SCIENTIST REPORT**: There was review of correspondence submitted by Joseph Theroux, Professional Soil Scientist, dated February 29, 2024. Mr. Theroux delineated inland wetlands on property. It was noted, entire yard is in upland review. This review was extensive.

**IWWC CONCERNS**: It was noted a significant amount of water flows off Route 395 in the area of this property. Members referenced the soil scientist report as noted above. Areas of concern, include but are not limited to, sediment/toxicant retention and nutrient removal and retention and the potential for a negative impact as the result of activities associated to this application.

Mr. Thibeault respectfully noted there would not be a negative impact to sediment/toxicant retention and nutrient removal/retention because the actual area of water run-off does not impact the area of activity associated to this application. Additionally, functionality of existing wetlands would not be negatively affected. A significant amount of water run-off collects along the roadway in a sausage style and not on property.

IWWC members are concerned there is no actual need for filling of wetlands as proposed; and as this measure does not solve existing water issues. It was highly recommended Mr. Thibeault propose alternate and prudent modifications to this application associated to proposed filling of wetlands.
