- IV. Adoption of Minutes review / discussion / action
  - A) Regular Meeting of October 10, 2018 No quorum no votes
  - B) Regular Meeting of September 12, 2018 Byron Martin motion to adopt, Virginia Keith seconded the motion, not further discussion, vote 4/0, minutes were adopted.
- V. CT Department of Agriculture 2018 Farm Viability Grant Guidance Document review / discussion / action Virginia Keith stated the NE Farmers' Market Association was submitting a grant proposal to help to relocate the Spring Summer and Fall Farmers' Market to Davis Park. She met with Paul Hopkins, Acting Town Manager and was supportive of the idea, this would give the public a reason to go Davis Park and not just drive by. Virginia asked if it would be possible to get letters of support for the proposal from the Agriculture Commission and the Town Manager's Office. Frank asked Ann-Marie to please write the letter for the Ag Comm and he would come into town hall and sign it. Ann-Marie said she would also write the letter for the Town Manager and send it to him for signature. Virginia stated the grant proposal was due into the State on or before November 20, 2018.
- VI. Real Estate Parcels Classified under Section 490 review / discussion / action
  - Ann-Marie presented a map to the commission members that showed all the real estate under Section 490 (a tax ID for farmland and forest parcels). Farm was 610 and shown in light green; Forest was 620 and shown in dark green. There was discussion to send letters to both "farm land and forest land" owners to determine which parcels were actively farmed, or managed forest. The commission would like to create a survey of questions to ask to see if the commission could determine what people wanted or needed from the Ag Comm. Discussion to continue at the next meeting in December, hope to get the letter and survey completed and sent out by the end of January, 2019.
- VII. Regulations review / revisions / discussion / action

Motion was made by Byron Martin to open the floor for discussion and to allow Paul Archer, LS, to take part in the conversation; Virginia Keith seconded the motion; no further discussion; vote 4/0; motion passed.

#### A) Proposed Regulations for "Adaptive Re-Use of an Agricultural Building

Ann-Marie did an introductory explanation of the proposed regulations for the adaptive re-use of an agricultural building. Paul Archer introduced himself to the commission and he discussed the reason behind bringing the proposal to the Ag Comm. Stated that the regulations before the Commission were actually a copy of the regulations the Town of Brooklyn has in place, and they have been very useful and successful for the Brooklyn Community. Frank and Byron explained that the Ag Comm was formed to actually support and assist agriculture to grow in Killingly, they did not think that "preservation and reuse of agricultural buildings" was actually something they should put within the Agricultural Section of the Zoning Regulations. Though the group supported the concept, the group was honest in stating they would like to see all agricultural buildings used for agriculture. Ann-Marie and Paul explained that before they brought the concept before the PZC they wanted the Ag Comm to review them, because they knew they would be asked by the PZC if the Ag Comm knew about and supported the proposed regulations.

Frank explained that though they supported the regulations, the proposed regulations regarding the buildings does not fit within the Agricultural Section of the Zoning Regulations; however, that does not mean that it could not go into another section of the Zoning Regulations.

Frank offered a letter of support, when the time called for it, to be written to the PZC to let them know the proposed regulations were presented to the Ag Comm, that the members did review them, and feel they belong in their own section of the zoning regulations.
