- I. **Call to Order and Roll Call – 7:04.** Frank Anastasio, Virginia Keith, Byron Martin, and Christel Shaw (arrived at 7:19). Absent with notice: Jim Stevens, Tina Stevens; Adam Griffiths, Council Liaison. Jonathan Blake, Eric Rumsey, Staff Liaisons.
