- Bus Tours The commission discussed previous bus tours. The commission came to a
 consensus to hold a bus tour in mid to late March. Potential routes for future tours included along
 River Road, by the stone house, along Valley Road where the trolley line was, and Cat Hollow.

- 3. Town Open Space / Inventory of Potential Properties for Open Space Preservation Tabled
- 4. Signs & Kiosks for Conservation areas Chase Reservoir An overview of the signs and kiosks at the 1892 was given. Shane suggested that the 1892 brochure be added to the website. The commission reviewed the proposed kiosk for Chase Reservoir. Several edits were made including: making Chase Reservoir blue, adding the trail lengths to the map (in miles), the trail signs and fishing sign larger, and add pavement width vs. centerline of road as shown. Pictures could be added to the map showing the gates and trail heads as well as the fishing spot. The commission discussed Quandoc and the needs of the kiosk including text and map updates as well as a trailhead marker.
