- I. **Call to Order:** The meeting was called to order at 7:00pm.

KCC members and staff will meet June 1st at 10AM at 1892/Sherman Memorial to walk and discuss improvements.
- c. **Quandoc – Rock Bridge:** The rock bridge used to cross the stream at Quandoc was destroyed. Discussed who will fix it and how to prevent it from happening again. Discussed trail cameras at Quandoc. Someone has also been leaving containers of chicken at Quandoc to feed the wildlife. Mike and friend are discussing adding another trail.
- d. **Future Events – Bus Tours, Springfest:** Springfest went well. Discussed scheduling another bus tour in the near future.
- e. **Chairperson Updates:** Jean made a motion to approve Donna's purchase of easels for \$29.76; Mike seconded; passed 3-0.
