- b. Special Meeting/Workshop June 1st, 2022: The workshop minutes were passed.

V. Business

- a. Properties 1892/Sherman Memorial (To-Do List), Chase Reservoir, Quandoc: For Sherman Memorial/1892, improvements need to be made to the brochure, the kiosk needs to be updated, a private property sign should be placed on the ATV path to the right, ECFLA will replace the bridges on their side, brush cutter, fallen trees, trail marking. Allison and Ann-Marie will check on the Chase Reservoir forestry management plan. For Quandoc, fixing the rock bridge was discussed and preventing ATV/four-wheelers was discussed. Mike made a motion to mark and adopt Quandoc's new blue trail; Jean seconded; passed 4-0. Mike made a motion to adopt orange, yellow, and blue as the paint colors for Killingly's trails; Jean seconded; passed 4-0.
- **b.** Litchfield Ave: Reviewed the Litchfield Avenue packet. Discussed where to park, discussed if there's an easement that runs through the proposed second entrance. discussed if boating/fishing was safe considering the proximity of the dam. Mike made a motion to have
