**T**own Government. Killingly’s form of government, established by the Town Charter, is Town Meeting, Town Council, Town Manager. The Town Council is the legislative body of Town government and the Town Manager is the Chief Executive Officer of the Town. The Town Council regularly meets the second Tuesday of each month at 7:00 PM in the Town Meeting Room on the second floor of the Killingly Town Hall located at 172 Main Street.

**Animal Control (Regional).** The Regional Animal Control Department (aka Dog Pound) is operated by the Northeastern Connecticut Council of Governments, located at 125 Putnam Pike in Killingly.

Hours: Monday - Friday 8:30 AM - 4:30 PM & appointment only by calling 860-774-1253. Ask to speak to Animal Control.

Please remember that the Town Clerk's Office, located in the Town Hall, 172 Main Street, Killingly, still handles the issuance of the dog licenses. Any questions on licensing, please call the Town Clerk at 860-779-5307.

**Assessor's Office.** The Assessor's Office is responsible for preparing the Town's annual Grand List of taxable properties which accounts for approximately 50% of the Town's operating revenues. Both Real Estate and Personal Property (including Motor Vehicles) are taxable in Connecticut. Some key information to know is:

- Real Estate is inspected by assessment staff after the recording of sale transfers; as needed based on building permits; and as required by law for revaluation.
- The only Personal Property that does not need to be claimed annually to the local Assessor on October 1<sup>st</sup> is Connecticut registered motor vehicles.
- Exemptions that reduce assessments are available for veterans, disabled, blind, farmers, public safety volunteers & businesses.
- Tax abatements are available for elderly and disabled homeowners.

**B**uilding Safety/Inspections. The Building Office administers all provisions of the Connecticut Basic Building Code and Connecticut Fire Safety Code for new construction, additions and repairs. The Office is also responsible for the issuance of burning permits, monitoring solid waste container violations, inspecting places of assembly, fire investigations and inspections of rental units under the Town's Housing Code.

**E****ngineering.** The Engineering Department provides technical support and advice to Town Departments & various commissions including Planning & Zoning, Inlands Wetlands & Watercourses, Water Pollution Control Authority and Solid Waste. The Department is also responsible for issuing driveway permits, maintenance and inspection of road opening permits and other excavations in Town roads; oversight of major capital projects such as building roads, sewers and drainage projects and business directional signage.

**F****inance.** The Finance Department is responsible for the financial and accounting operations of all Town funds. The Department handles accounts payable, accounts receivable, purchasing, payroll and employee benefits administration, fixed asset management and internal and external auditing. The Department also oversees the annual audit process and prepares Town financial statements and statistical reports.

The Town Treasurer is responsible for all deposited funds of the Town and for maintaining the integrity of cash and other assets as well as debt management.

**F****ire Marshal.** The Fire Marshal investigates the cause, origin and circumstance of all fires within his or her jurisdiction.

Other duties include:

- Serves as principle inspector of buildings and facilities in the Town
- Plan Reviews: Fire alarms, sprinklers
- Assists in planning and management to emergency response to hazardous materials in the Town
- Open Burning Official/Illegal burning complaints
- Portable tents/fireworks inspections
- Blasting permit applications
- Propane & oil trucks; Haz-mat annual certificates
- Assists as Deputy Emergency Management Director in preparing emergency plans for natural disasters

**Housing Authority.** The Town of Killingly Housing Authority owns and manages 120 units of low/moderate income elderly housing and 43 units of congregate housing at its three locations: Maple Courts I & II on Maple Street, Danielson and Birchwood Terrace, Danielson. In addition, the Authority administers 85 Federal Section 8 Vouchers. When there are no vacancies, a waiting list is maintained for all programs. The Housing Office is located at 620 Upper Maple St. in Maple Court II.

**Law Enforcement.** The Killingly Resident State Troopers provide law enforcement services in the Town. There are currently four Resident Troopers, typically with two on the day shift and two on the evening shift. The Town's Resident Troopers are supported by the State Troopers of Troop D. The Resident Troopers' Office is located at 172 Main Street, on the second floor, in the Town Hall.

**Parks and Recreation.** The Killingly Parks & Recreation Department is located in the Community Center at 185 Broad St. and provides a wide variety of recreational opportunities for the residents of Killingly and the surrounding area. Programs include athletics, arts and crafts, fitness and continued learning along with summer outdoor activities, Camp Wallaby and the summer concert series. Special events and family activities include The Great Killingly Tomato Festival, the Red, White & Blue BBQ and the annual Killingly Bike Night along with other smaller seasonal events of Frosty's Big Night Out, Breakfast with Santa and Breakfast with the Bunny. The Little Theatre on Broad Street hosts several productions throughout the year, with a strong concentration on involvement in community theatre for both adults and children.

The flagship park, Owen Bell, boasts multiple sport playing fields along with a walking track and trails. Basketball, tennis courts and a skate park are available, as well as a tot and Boundless playground. A splash pad is available seasonally and pavilions provide picnic areas throughout the park. Other parks in Killingly are Davis Park, Danielson Lions Park, Cat Hollow, Chase Reservoir, Mason Hill, Phaiah Dog Park, located along the River Trail, a walking, jogging, biking trail and Hygeia Reservoir, which is open seasonally. **All Parks are open from sunrise to sunset.**

**P**lanning and Development. Start with this office to apply for both zoning and building permits for new construction (houses, additions, sheds, garages, decks, swimming pools, etc.) or for changing the use of a property or building. To avoid delays, contact this department early in your planning as some projects may require several land use or commission (i.e. wetlands) approvals. We can help guide you through the permitting process.



**Zoning.** For a zoning permit, bring a plot or site plan, know the structure's size, proposed use, location, and its "setbacks" (the closest distances from all property lines to the outermost edges of the structure). Is there excavation or filling involved? If so, know the volume (cubic yards) and area of the work to be done. If you are not the property owner, you will need the owner's written authorization. Houses built on vacant lots that are not part of an approved subdivision also require a chain of title letter from an attorney verifying the lot's legal creation.

Two weeks notice is needed for zoning Certificate of Compliance inspections before you can get your Certificate of Occupancy from the Building Official. Call us for the permit fees or with any questions you may have regarding land use in Killingly. **For regulations concerning Town Zoning, Borough Zoning, Subdivisions and Wetlands , please go to the Town website.**

**P**ublic Works. The Public Works/Highway Division, located at 79 Putnam Pike, is responsible for maintaining approximately 130 miles of roads both improved and unimproved. This includes snow removal, road surface repair, drainage improvements and repairs, street sweeping, drain cleaning, roadside mowing and litter removal, street sign replacement, other signs on the roadways, pavement markings and other daily activities needed to keep Killingly clean and safe for our citizens.

**R**ecycling Center. This Department includes the Transfer Station and Recycling Center located at 246 Brickhouse Rd. Residents who wish to dispose of mixed household waste and recyclables must purchase a permit (\$80.00 per year, \$40.00 for Seniors or \$20.00 for a 3-Visit Pass) in the Revenue Collector's Office and utilize Town stickers for the waste at a cost of \$5.00 each. Stickers are available at Stop & Shop, Big Y and Sunnyside Farms. No bag larger than 35 gallons may be used to dispose of household trash. Items such as newspaper, bottles, cans, cardboard, metal, electronics and other items that can be recycled may be brought to the Center. Construction debris and furniture known as Bulky Waste may be disposed of at a cost of \$0.10 per pound. There is no fee for recyclables or disposal of electronics. Cash is not accepted at the Transfer Center & Recycling Center.

**Revenue Collector.** The Revenue Office collects Real Estate, Motor Vehicle and Personal Property taxes as well as Sewer Use and Assessment Charges. Need a Recycling Center and Transfer Station permit? Stop in with your vehicle registration (see Recycling Center page 9 for additional details). In July of 2013, the Borough of Danielson contracted with the Town to collect Borough taxes along with the Town tax.

**Important Dates to remember:** All Motor Vehicle, Real and Personal Property less than \$100 are due in full in July. Real and Personal Property over \$100 may be paid in quarterly installments due July 1<sup>st</sup>, October 1<sup>st</sup>, January 1<sup>st</sup> and April 1<sup>st</sup> of each year. An additional Motor Vehicle billing, the supplemental motor vehicle, is due in January. Residential Sewer Use may be paid in two installments due July 1<sup>st</sup> and January 1<sup>st</sup>. Metered Sewer Use may be paid in two installments due September 1<sup>st</sup> and March 1<sup>st</sup>. Sewer Assessments are due in full in June.

***No separate mailing will be sent for installments. Bills are mailed once a year.*** Interest on late payments is 18% annually, calculated from the due date.

**How Do I Pay My Bill?** You may pay your bill in our office, online through our website, through your bank's online banking system, by using the drop box located in the rear parking lot near the handicap ramp or by mail. Our mailing address is 172 Main St., Killingly, CT 06239. When paying by mail, write your list number(s) on your check or money order, and make payable to the "Town of Killingly" along with one copy of your bill. If a receipt is desired, send a stamped, self-addressed envelope. Staff is available at the Town Hall, 172 Main Street, M-W-Th: 8:00 AM-4:30 PM; Tu: 8:00 AM-5:30 PM; Fri: 8:00 AM-11:30 AM, to accept your payment in person.

If you own a property on the tax due date, you have assumed the tax responsibility for that property. To avoid interest charges check with the collector or on our website to see if you have a balance due and to make sure that we have your most current address.

**Water Pollution Control Authority (WPCA)** The WPCA is responsible for the operation of the wastewater treatment plant located at 31 Wauregan Rd. The plant is operated by Suez, under contract to the Town of Killingly and the Killingly Water Pollution Control Authority. The Treatment Plant handles approximately 3,000,000 gallons of wastewater and 10,000 gallons of septic per day. The WPCA is responsible for maintaining 45 miles of sewers, 1,300 manholes and 12 pump stations. The WPCA meets on the third Wednesday of the month at the Town Hall Meeting Room. The Killingly Engineering Department is responsible for the day to day operations of the system. Sewer connection permits can be obtained at the Treatment Plant.

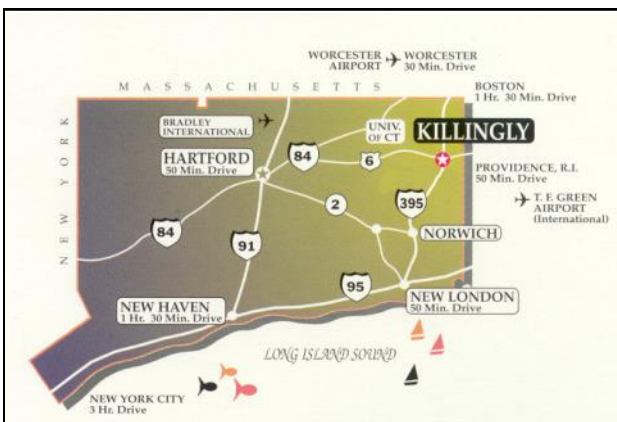

- Recycling center permits may be obtained at the Revenue Office. (Stickers are available at local stores and transfer station.)
- Dog licenses may be obtained from the Town Clerk's Office.
- Repairs, replacements or additions to your home or business may require a permit. Contact the Planning & Development Office.
- Pistol Permit applications may be obtained in the Town Clerk or Town Manager's Offices.
- Registering your child for school. Call the Superintendent's Office.
