# KILLINGLY HOUSING AUTHORITY MAPLE COURT II NOV. 19, 2019 MINUTES OF REGULAR MEETING

The Meeting was called to order at 6:58 P.M. by Chairman Pappas.

- 1. Roll Call: Present was Roxanne Pappas, Robert Loiselle and David Smith. Also present was Carol Greene, Executive Director and David Griffiths, member of the Killingly Town Council.
- 2. It was moved by Robert Loiselle, seconded by David Smith, to approve the minutes of the Regular Meeting of the Town of Killingly Housing Authority held on Oct. 15, 2019. The vote to approve the minutes was unanimous.
- 3. It was moved by Robert Loiselle, seconded by David Smith, to approve as presented, the Treasurer's Report for Oct., 2019 for Maple Courts and Birchwood Terrace. The vote to accept the report passed unanimously.

# RESOLUTION #5-2019 NOVEMBER 19, 2019 FINANCING FOR BIRCHWOOD TERRACE ROOF REPLACEMENTS

- WHEREAS, the Housing Authority of the Town of Killingly has an immediate need to replace all five roofs at the Birchwood Terrace property to protect the buildings from damage and ensure safety and health of the tenants. These units are located at 41 Birchwood Terrace, Danielson, CT CHFA Development No. 85087D; and
- WHEREAS, the Housing Authority of the Town of Killingly has been authorized by Connecticut Housing Finance Authority to submit an application for a thirty year, interest free, forgivable loan to replace the leaking roofs at Birchwood Terrace.

NOW THEREFORE, BE IT RESOLVED THAT THE HOUSING AUTHORITY OF THE TOWN OF KILLINGLY:

- 1. Is cognizant of the conditions of and prerequisites for financial assistance in the form of a loan from the Connecticut Housing Finance Authority.
- 2. That the Executive Director of the Town of Killingly Housing Authority is hereby authorized and directed to provide information,

execute all documents required by Connecticut Housing Finance Authority to complete financing, execute contracts for design and construction, and to execute any amendments, rescissions and revisions thereto, and to act as the authorized representative of the Housing Authority of the Town of Killingly for the replacement of these five roofs.
