**RESOLUTION SETTING THE PROPERTY TAX MILL RATE
FOR FISCAL YEAR 2020-2021**

BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF KILLINGLY that a tax rate of _____ mills be set for the fiscal year July 1, 2020 to June 30, 2021.

BE IT FURTHER RESOLVED that taxes for the fiscal year July 1, 2020 to June 30, 2021 shall be due and payable as follows:

1. All real estate and personal property taxes over \$100 are due in quarterly installments on July 1, 2020; October 1, 2020; January 1, 2021; and, April 1, 2021.
2. Real estate and personal property taxes under \$100 and all motor vehicle taxes will be due in full on July 1, 2020.
