A Special Meeting of the electors and citizens qualified to vote in Town Meetings of the Town of Killingly, Connecticut, shall be held, pursuant to Section 701(b) of the Killingly Town Charter, following the conclusion of the Town Council meeting to be held following the aforementioned public hearing in the Town Meeting Room of the Killingly Town Hall, 172 Main Street, Killingly, CT on Tuesday, May 10th, 2016 at 8PM for the following purpose:

ORDINANCE AUTHORIZING THE SALE OF A DISCONTINUED PORTION OF HUTCHINS STREET

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF KILLINGLY that the Town Manager is hereby authorized to sign and execute a quitclaim deed and such other documents as may be needed to convey, subject to a reserved sewer easement, the Town-owned real estate at the discontinued portion of Hutchins Street, said property being 0.20+/- acres of undeveloped land, to Eversource Energy, for the sum of \$6,800.
