# 1. Call to Order

Tracy Mason, Director of Parks and Recreation

M. Calorio opened the floor for nominations for Chairman. C. Walsh nominated Jason Anderson for the position of Chairman of the Fiscal Subcommittee, seconded by Jason Anderson.

Motion made by C. Walsh to close nominations, seconded by J. Anderson. Motion passed unanimously 2-0-0.

Motion naming Jason Anderson as Chairman passed 2-0-0.

Jason Anderson immediately began his duties as Chair.

3. Adoption of Minutes: September 17, 2019 Motion by C. Walsh to accept minutes. Second by J. Anderson. Motion carries unanimously.

### 5. New Business

- a. Discussion and possible action regarding installation of turf fields at Killingly High School Superintendent Rioux reviewed the facilities improvement presentation which outlined the current condition of the fields, proposed improvements to include the installation of a turf field at the stadium field location for a total cost of \$906,438. Mr. Rioux also presented several financing options and reviewed a grant awarded to the District for this project. The Members discussed the type of product to be installed, the difference in athlete injury rate of turf compared to grass, timing of project and financing options. Superintendent Rioux requested the subcommittee consider recommending a \$500,000 appropriation from Fund Balance to fund the down payment of the project. Town Manager Calorio reviewed the Town's Fund Balance position and concurred the Town's Fund Balance was sufficient to fund this request. The Members discussed the Fund Balance and the balance of the Unexpended Fund. Mr. Anderson made a motion to recommend project with a Fund Balance appropriation of \$300,000 to the Town Council for approval. Second by Ms. Walsh. Motion carries unanimously.
- b. Discussion and possible action regarding the appropriation of LOCIP funding to resurface Owen Bell's rubberized playground surface

Town Manager Calorio reviewed the current conditions of the playground surface at Owen Bell and the proposed replacement surface material and cost. Parks Director Mason discussed the installation process. Members discussed the proposed new surface, cost estimates and timing. Ms. Walsh made a motion to recommend the appropriation of \$80,000 of LOCIP funding for the Owen Bell playground resurfacing project to the Town Council for approval. Second by Mr. Anderson. Motion carries unanimously

# THOMAS J. EVANS

VOTED: That the Town accept the legacy of Three Thousand Dollars of Thomas J. Evans, Esq. in accordance with the provisions of his will and that the Selectmen be trustee of said fund.

# SHUBAEL HUTCHINS

VOTED; Whereas the late Shubael Hutchins Esq., of the City of Providence R. I. did in his last will and Testament - bequeath a legacy of Five Thousand Bollars to the town of Killingly in Trust, the income of which to be used for the benefit of the poor and sick, indigent widows especially, and whereas the Executors of the said Hutchins Estate have notified the town that they are ready to pay over the said legacy, provided the town wishes to accept the same with its trusts and conditions and will appoint certain persons: to receive the same on behalf of the town and receipt for the same to the said Trustee, therefore be it hereby, Resolved and voted: That the legal voters of the Town of Killingly in this meeting duly and lawfully called and convened do hereby gladly and thankfully accept and receive with the conditions imposed the legacy of Five Thousand Dollars, bequeath by the commendable fore thought and kind = = = = generosity of our esteemed once fellow towns man; the late. Shubael Hutchins Esq. of Providence R.I. and that we do hereby appoint empower and authorize the Clerk of the Selectmen and the Town Treasurer of this said Town of Killingly, in behalf of and for the Town to receive from the said

Trustee, and receipt to them for the said legacy of Five Thousand Dollars

Be it resolved and voted: That the Town Treasurer of the Town of Killingly Exofficio be and he is hereby made and appointed the Trustee of this said Shubael Hutchins Fund (so be called) in behalf of the Town that he be and he is hereby instructed to Loan the same to the Town of Killingly on the note of the said Town of Killingly duly executed to him the said Trustee, at the rate of five per centum per annum, payable semi-annually.

Be it resolved and voted: That the three selectmen oliver W. Bowen, Charles E. Ayer, and Albert W. Greenslit be and they are hereby appointed and made the Committee of three for the dispensing of the income of this said fund, that they be hereby instructed to follow very carefully the terms of the legacy in dispensing the said income and that they make a report in writing to the next annual town meeting of their doing in said trust.

Voted: Town Meeting March 20, 1893

# TOWN DEPOSIT FUND

Voted: That William Alexander be and he hereby is appointed the agent of this town to receive from the Treasurer of this State the proportion of the said money belonging to this town and the said agent is authorized to sign a receipt therefor conformably to the requirements of the said act of this state and which receipt shall be obligatory on this town.

Voted: Town Meeting January 30, 1837


