Earl has given thousands of hours to research power plants and how they affect the air, water, and landscape of a neighborhood, regional towns, and the state as a whole.

He worked tirelessly with groups opposed to the proposed (and defeated) Burrillville , RI Invenergy project. 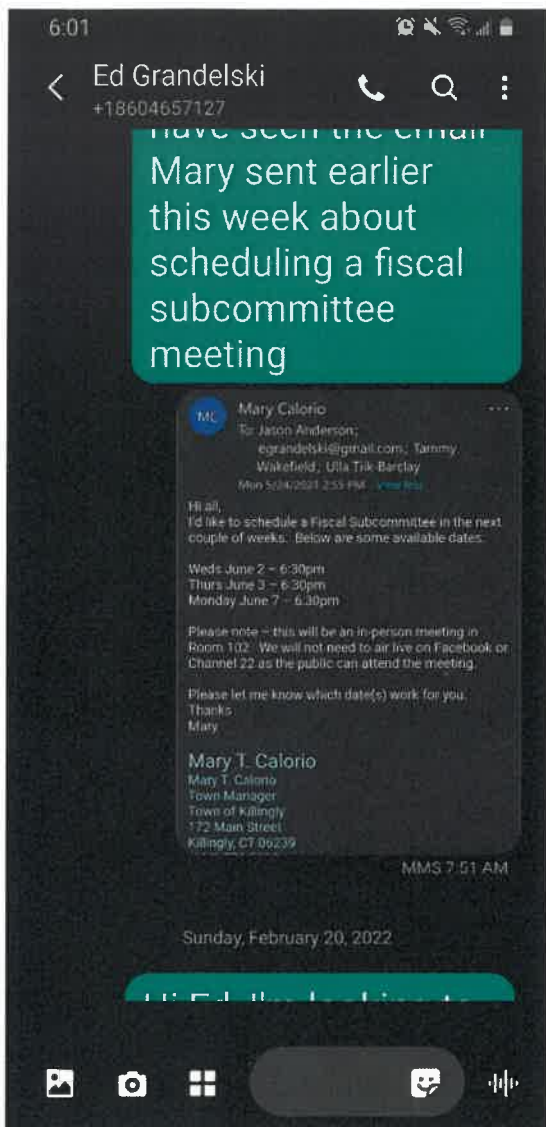

Dear fellow Town Council Members and citizens,

Since I was elected in November 2017 it has been an honor to serve this community. I am thankful for the opportunity to be able to give back to this great community. I have humbly worked alongside fellow council members and Town administration through whom I have learned so much from and have the utmost respect for. I have always done my best to treat those I work with fairly and justly while performing all the responsibilities that come along with serving initially as vice-chairman and currently as chairman. While I may have had opinions that differed from other Council members and Town staff I have always treated them with respect and professional courtesy. Unfortunately due to public comment submitted for Sunday's Council goal setting meeting by fellow Council member Mr. Grandelski I feel that I need to clarify a few things. Mr. Grandelski was involved in the planning of the original goal setting meeting date and time that was cancelled due to weather. I afforded him the opportunity to have input into the date and time of the rescheduled meeting, unfortunately as he has previously he did not respond to me. As you can see from the text message screenshots I have attached, Mr. Grandelski has a history of not responding to me when I reach out to him. Furthermore, notification was sent to Mr. Grandelski's town email prior to the March 1st Town Council meeting. In 2020 I notified Mr Grandelski about a Special Town Council meeting that had been scheduled before I contacting any other Council members, I then called him the night prior to the meeting to remind him of the meeting at which time he thanked me for calling him and requested to meet me at KIS to discuss a few concerns he had there. I met Mr. Grandelski and we spoke for approximately 45 minutes the morning of the



meeting. During those three conversations Mr. Grandelski never expressed any concerns or issues with only 6 days' notice of the meeting prior to it being held. Instead during that Special Town Council meeting he accused me of rushing the scheduling of the meeting and not notifying him sooner. His actions lead me to believe he waited until the meeting to voice these concerns for politically motivated purposes. The fact is he was notified 5 days sooner than what is required and I notified him before I notified any of the Republican Council members. It would be greatly appreciated if Mr. Grandelski would afford me the courtesy and respect I have and always will afford him.
