SPECIAL TOWN MEETING MINUTES

A Special Town Meeting of the electors and citizens qualified to vote in Town Meetings of the Town of Killingly, Connecticut, shall be held, pursuant to Section 1008 of the Killingly Town Charter, to be held in the Town Meeting Room of the Killingly Town Hall, 172 Main Street, Killingly, CT on August 8, 2023 at 8:00 pm for the following purpose:

**ORDINANCE #1 TO AUTHORIZE THE SALE OF TOWN
PROPERTY AT 125 ALEXANDER PARKWAY.**

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF KILLINGLY that the Town Manager is hereby authorized to enter into the Purchase and Sale Agreement with NE Edge, LLC. of East Greenwich, RI, to purchase real estate as shown in Exhibit "A", a 39-acre parcel, more or less, subject to further delineation as a survey may show, known as 125 Alexander Parkway, Killingly, CT.

BE IT FURTHER ORDAINED that the purchase price shall be \$5,004,800 of which \$500,000 to be credited to the Economic Development Trust Fund and the remaining funds be credited to the Capital Projects Fund.

**ORDINANCE #2 AUTHORIZING A TRANSFER OF UP TO \$746,742 TO
THE ESTABLISHED UNEXPENDED EDUCATION FUNDS ACCOUNT**

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF KILLINGLY that a transfer of up to \$746,742 for the fiscal year July 1, 2021 to June 30, 2022 be transferred to the established Unexpended Education Funds account.

BE IT FURTHER ORDAINED that the source of said transfer shall be up to \$746,742 from the 2021-2022 fiscal year anticipated surplus be transferred to the established Unexpended Education Funds account.

BE IT FURTHER ORDAINED that said transfer be herein submitted to a Special Town Meeting for adoption on August 8, 2023 at 8:00 p.m. in the Town Meeting Room of the Killingly Town Hall, 172 Main Street, Killingly, Connecticut, and
