TOWN OF KILLINGLY PUBLIC HEARING October 13, 2015

A PUBLIC HEARING of the Town Council was held, pursuant to Section 506 of the Killingly Town Charter, in the Town Meeting Room of the Killingly Town Hall, 172 Main Street in Killingly, Connecticut, on Tuesday, October 13, 2015 at 7:00 p.m. at which time interested persons were heard upon the following:

ORDINANCE TO AMEND CHAPTER 13, STREETS, SIDEWALKS AND PUBLIC PLACES, ARTICLE 1. IN GENERAL, SECTIONS 13.2, (b)(c)(d)(e)(f)

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF KILLINGLY that the Killingly Code of Ordinances, Chapter 13, STREETS, SIDEWALKS AND PUBLIC PLACES, ARTICLE 1: IN GENERAL, Section 13.2 be amended by the addition following <u>underlined</u> provisions:

Chapter 13

STREETS, SIDEWALKS AND PUBLIC PLACES

Section 13.1 Liability of Town for snow and ice removal of public sidewalks

- (a) Pursuant to Public Act 81-340 the town shall not be liable to any person injured in person or property caused by the presence of ice or snow on a public sidewalk unless the town is the owner or person in possession and control of land abutting such sidewalk, other than land used as a highway or street, provided such municipality shall be liable for its affirmative acts with respect to such sidewalk.
- (b) The owner or person in possession and control of land abutting a public sidewalk shall have the same duty of care with respect to the presence of ice and snow on such sidewalk toward the portion of the sidewalk abutting his property as the municipality had prior to the effective

date of this section and shall be liable to persons injured in person or property where a breach of said duty is the approximate cause of said injury.

(Ord. of 3-11-2003, § 13.1)

(c) No action to recover damages for injury to the person or to property caused by the presence of ice or snow on a public sidewalk against a person who owns or is in possession and control of land abutting a public sidewalk shall be brought but within two (2) years from the date when the injury is first sustained.

(Ord. of 12-17-81, §§ I, II)

Section 13.2 Maintenance of sidewalks

- (a) Generally the owner or owners of any property which abuts or is adjacent to a public sidewalk shall be responsible for maintaining as hereinafter required that portion of the sidewalk which is adjacent to his, her, or its property.
- (b) For the purpose of Snow and or Ice removal from public sidewalks not owned or maintained by the Town, the following paragraphs shall apply.
- (c) In the event of a snow storm with total accumulation of 8 inches or more, the Town of Killingly Highway Department or its designee will begin to remove the snow accumulated on the public sidewalks throughout the Town as soon as is it is safe for the employees to perform such tasks.
- (d) It is understood that in the instance of storm events spaced closely together, or other events beyond the control of the Highway Department, these procedures may be modified when deemed to be in the best interest of the Town of Killingly in order to better serve the overall public safety including but not limited to pedestrian and vehicular traffic, town employees, resources, materials and equipment. These decisions/variances are at the sole discretion of the Town Manager or his designee.
- (e) The snow fall accumulation amount shall be determined by a snow gauge installed at the Town's highway garage.
- (f) In situations not covered by the paragraphs above, removal of Snow, Ice, and Debris. Such owner shall remove any accumulation of ice, snow, or debris within twenty-four (24) hours after such ice and snow has ceased to accumulate or such debris have been deposited, and if such owner shall fail to remove said accumulation of snow and ice or debris as aforesaid, the Town Manager may, but shall not be required to, cause the same to be removed at the expense of the Town, which expense shall be billed to and payable by the owner of the subject premises. If the owner of the subject premises shall fail to pay such costs within thirty (30) days of receipt of a bill for the same from the Town, the Town Manager is hereby authorized, pursuant to the provisions of 7-148 (c) (6) (C) (v) of the Connecticut General Statutes, to make the cost of such removal a lien on the property of the owner. Such lien shall be enforced and collected in the same manner as provided by law for the collection and enforcement of tax liens. In any circumstances where it is not practical to remove ice and

snow, the sidewalk shall be temporarily sanded by the owner thereof in order to provide as safe as possible pedestrian access across said sidewalk.

16a) Consideration and action on an ordinance to amend the Killingly Code of Ordinances, Chapter 13-Streets, Sidewalks and Public Places, Article 1, Section 13.2-Maintenance of sidewalks

Mr. Sarantopoulos made a motion, seconded by Ms. LaBerge, to adopt the following:

ORDINANCE TO AMEND THE KILLINGLY CODE OF ORDINANCES, CHAPTER 13-STREETS, SIDEWALKS AND PUBLIC PLACES, ARTICLE 1, SECTION 13.2-MAINTENANCE OF SIDEWALKS

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF KILLINGLY that the Killingly Code of Ordinances, Chapter 13-Streets, Sidewalks and Public Places, Article1, Section 13.2-Maintenance of sidewalks, be amended by the addition of the following <u>underlined</u> provisions:

Chapter 13 STREETS, SIDEWALKS AND PUBLIC PLACES ARTICLE I. IN GENERAL^[2]

Section 13.2 Maintenance of sidewalks

- (a) Generally the owner or owners of any property which abuts or is adjacent to a public sidewalk shall be responsible for maintaining as hereinafter required that portion of the sidewalk which is adjacent to his, her, or its property.
- (b) For the purpose of Snow and or Ice removal from public sidewalks not owned or maintained by the Town, the following paragraphs shall apply.
- (c) In the event of a snow storm with total accumulation of 8 inches or more, the Town of

- Killingly Highway Department or its designee will begin to remove the snow accumulated on the public sidewalks throughout the Town as soon as is it is safe for the employees to perform such tasks.
- (d) It is understood that in the instance of storm events spaced closely together, or other events beyond the control of the Highway Department, these procedures may be modified when deemed to be in the best interest of the Town of Killingly in order to better serve the overall public safety including but not limited to pedestrian and vehicular traffic, town employees, resources, materials and equipment. These decisions/variances are at the sole discretion of the Town Manager or his designee.
- (e) The snow fall accumulation amount shall be determined by a snow gauge installed at the Town's highway garage.
- (f) In situations not covered by the paragraphs above, removal of Snow, Ice, and Debris. Such owner shall remove any accumulation of ice, snow, or debris within twenty-four (24) hours after such ice and snow has ceased to accumulate or such debris have been deposited, and if such owner shall fail to remove said accumulation of snow and ice or debris as aforesaid, the Town Manager may, but shall not be required to, cause the same to be removed at the expense of the Town, which expense shall be billed to and payable by the owner of the subject premises. If the owner of the subject premises shall fail to pay such costs within thirty (30) days of receipt of a bill for the same from the Town, the Town Manager is hereby authorized, pursuant to the provisions of 7-148 (c) (6) (C) (v) of the Connecticut General Statutes, to make the cost of such removal a lien on the property of the owner. Such lien shall be enforced and collected in the same manner as provided by law for the collection and enforcement of tax liens. In any circumstances where it is not practical to remove ice and snow, the sidewalk shall be temporarily sanded by the owner thereof in order to provide as safe as possible pedestrian access across said sidewalk.

BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF KILLINGLY that in the event that Fuel Cell Energy, Inc. elects to construct its approximately 11.2 megawatt power generation plant in Killingly, the Town, as authorized under Killingly Code of Ordinances, Section 14-6, will abate the taxes due on the personal property of Fuel Cell, Inc. for a period of ten years. Fuel Cell Energy will be assessed fixed payments lieu of actual assessment in the amount of \$200,000 per year for five years and \$220,000 per year for the final five years. This commitment is subject to agreement between the two parties on other terms that may be contained in a formal tax abatement agreement, and it is subject to a legal review of said agreement.
